10. Electronic Fund Transfer	Transfer of allowances of beneficiaries under social safety net (G2P) through electronic system has been inaugurated by the Hon'ble Prime Minister on 17 July, 2018 that initially covered 1,28,282 beneficiaries;
11. Livelihood Development Programs for Transgender Bede communities and Tea Garden Laborer	With the slogan of "Leaving no one behind" the Ministry initiated socio-economic development program for Hijra (Transgender), Bede (Gypsy), underprivileged community and tea-garden laborer. Income Generating Training and Allowances were provided to 31,800 Bede (Gypsy), 5,750 Hijra (Transgender) and 30,000 tea-garden labor respectively

12. Disable Service and help Centre	Disable Service and help Centre has earned the confidence of the patients. Till September 2018, help centre has provided 4.8 million services to 0.37 million registered patients and distributed 34346 assistive devices.
13. One Stop Mobile Therapy Service	Mobile Therapy Van providing the therapy services at door step of the people. Till September 2018, 0.58 services have been rendered to 0.27 million people.
14. Strong Legal Regime	For the protection of persons with disabilities and vulnerable people MoSW has already been enacted relevant Acts: and Policies

Programme Reforms

- Comprehensive Pension System for the Elderly (Age 60+) will be introduced soon
- Monthly rate of allowance would be Tk. 3000 for 90+ yrs
- Widow allowance, the beneficiaries age of 60+ years shifted to Old Age Allowance.

Institutional Reforms

- ► MIS Established Under DSS
- ► G2P Payment Started
- ➤ Beneficiary Selection will be done through online application
- ► GRS Provision Kept in MIS
- ➤ Monitoring & Evaluation Will be done through MIS

Challenges

- Institutional Capacity
- Decentralization
- Lack of Information/no complete Data base about Elderly People
- Low coverage and low level of funding.
- Beneficiaries are illiterate and not familiar to modern payment system
- Increasing migration from rural areas & growing urbanization
- In beneficiary selection, have to increase poor & vulnerable people & exclude the non-poor
- No formal Monitoring & Evaluation (M&E) system

Key recommendations for Improving Social Security Program based on NSSS Action

- It is needed comprehensive and effective management of social security schemes.
- Form of National Single Registry can be established based on a network of independent but interlinked with scheme—specific MIS including House hold database & NID.
- Scheme-specific MIS that communicate with each other & deliver comprehensive information across government.
- Minimum age of 60 years for getting old age allowance.
