- ✓ To Ensure VGF Distribution to the Real Fishermen 'Fishermen Registration & Issuing of Identity Card Project' has been implemented between July 2012 to June 2017.
- ✓ Total Number of Fishermen registered upto date is 16.20 lakh and among them 14.20 lakh ID Card has been distributed.

Other Activities implemented by the Department of Fisheries (DoF) :

- ✓ 2577.40 Metric Ton rice as VGF has been distributed among 2630 fishers family adjacent to Halda River between 2011 to 2015
- ✓ Alternative Income Generating Activities (AIGA) for 84662 beneficiaries has been created through 'Jatka Conservation, Alternate Income Generation for the Jatka Fishers and Research Project', through 'Greater Kumilla District Fisheries Development Project' and ECOFish (Bd) Project.

Other Activities implemented by the DoF:

- ✓ 7142 nets has been distributed among fishermen groups through 'Greater Kumilla District Fisheries Development Project' and 'Poverty reduction and livelihoods Security for the People of Economically Depressed Area Project'
- ✓ Total Tk. 289.70 Lakh has been distributed among 587 fishermen family for accidental death of fishemen through Fishermen Registration & Issuing of Identity Card Project.

Other Activities under implementation by the DoF :

- ✓ Formulation and Finalization of a Guideline for Fishermen Registration and Distribution of Identity Card to the Fishermen is under approval process.
- ✓ 'Guideline for distributing financial support to the deceased of permanently disabled fishers family' is also under approval process.

Other Activities under implementation by DoF :

- ✓ A primary initiative with the help of ECOFish (Bd) Project has been taken to form a trust fund to support the fishermen in the crisis period.
- ✓ Total Tk. 350 Lakh has been allotted and 232.00 lakh has already been transferred to a bank account created in this purpose.

Other Activities of Action Plan to be Implemented :

- ✓ Covering 100% registered fishers under VGF Programme;
- ✓ Publish list of beneficiaries through online to make the process transparent;
- ✓ Prepare online base MIS for Social Safety Net Programme and make it accessible by relevant departments; and
- ✓ Link the MIS with cash disbursement.
