- ▶ Financial assistance for entrepreneurship

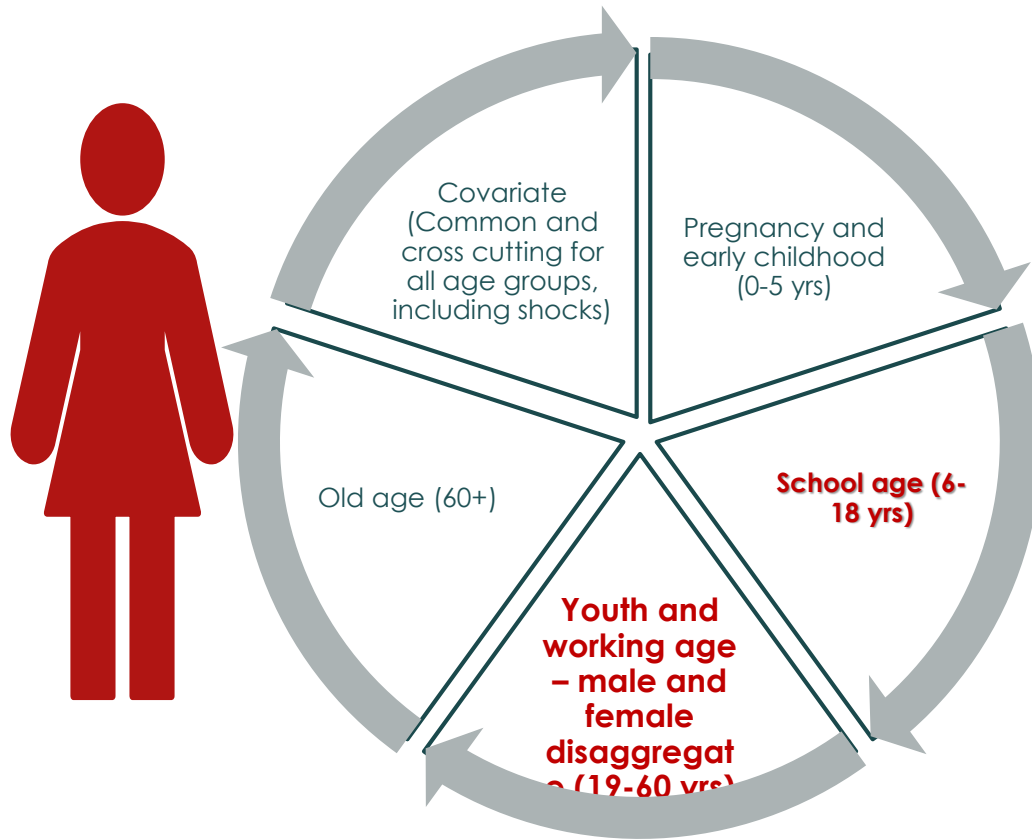
Time period of the programme/scheme/project/activity

1. **Skill Development Training Centres:** 80 Unites 25000 Capacity for 18-45 years
2. **Development of the Living Standard of the Marginal People of Bangladesh project:** 18 to 50 years, 8 district, target 7000 person
3. **Destitute Children's Training and Rehabilitation Program:** 3 centers, 6-18 years, 750 children
4. **Bede and Marginalized persons training and financial support:** all over country, 2500 persons per year, 18-50 years
5. **Hijra persons training and financial support:** all over country: 1350 per year, 18-50 years
6. **Children's Development Centres:** 3 Centres, 1000 per year, 12-18 years
7. **Safe Homes for Girls and Women:** 6 centres, 600 seats, 12+ years
8. **Government Shelter Homes:** 6 Centres, 600 seats, 12+ years
9. **Socially Disadvantaged girls Training and Rehabilitation Program:** 6 centres, 600 per year, 18+ girls and women
10. **Training and Rehabilitation Centers for PWDs:** 7 Centers, 700 per year, 18+ PWDs
11. **Rural Social Services Programme (RSS):** all Upazila, training for micro finance beneficiaries
12. **Rural Mother Centre Programme:** training for micro finance beneficiaries

- i) Age, categories and vulnerabilities of beneficiary considered
- ii) Financial conditions of the beneficiary
- iii) Children/Girls/Women contact or conflict with law
- iv) Person with Disabilities

Challenges faced by Ministry/Agency in Implementing Social Security Programmes

- Lack of database about young skilled people for providing employment in different sectors;
- Coordination among ministries regarding Human Development.
- Lack of accurate statistics on educated unemployment/ Marginalized people;
- Lack of own training building
- Need assessment of local demand;
- Limited allocation for modernization of training centers;

- It is needed for the comprehensive and effective management System for Training Centres
- Individual budget for the resident should be increased
- It develop coordination among ministries regarding Human Development.
- To need accurate statistics on educated unemployment people
- To provide necessary skilled manpower in a profession;
- To need own training building;
- To need government allocation for modernization of training centers
