There are 12 Types of Disabilities in our National Disability Act

#### Autism Spectrum Disorder (ASD)

A range of developmental brain disorders affecting communication, behavior, and social interaction.

#### **Physical Disability**

Impairments impacting mobility or physical function, such as missing limbs or paralysis.

## Mental Illness Leading to Disability

Conditions like schizophrenia or depression that disrupt daily functioning.

#### **Visual Disability**

Impaired vision, including blindness, not correctable by standard treatments.

#### **Speech Disability**

Disorders affecting verbal communication, like stuttering or speech delay.

#### **Intellectual Disability**

Limitations in learning and adaptive behavior affecting everyday skills.

#### **Hearing Disability**

Partial or total hearing loss affecting communication and interaction.

#### **Deafblindness**

Combined severe hearing and vision impairments hindering environmental interaction.

#### Cerebral Palsy

Movement and coordination disorders caused by brain damage before or during birth.

#### **Down Syndrome**

A genetic disorder causing developmental delays and intellectual disabilities.

#### **Multiple Disabilities**

Coexistence of two or more disabilities requiring comprehensive support.

#### Other Disabilities

Emerging conditions or rare disorders significantly impacting daily life.
